Sub: Disclosure under Regulation 30 of SEBI (Listing Regulations and Disclosure Requirements), 2015

Ref: National Green Tribunal's order affecting the company's API Plant

This is to inform you that the company has established its bulk drugs facility at GIDC Panoli and the said plant has been operating under valid environmental clearance. This facility has been accorded environmental clearance by the Ministry of Environment & Forest, Government of India. This environmental clearance has been granted under and in accordance with EIA Notification dated 27th January, 1994 following circular dated 14th May, 2002 issued by the said Ministry ("the said Procedural Circular").

Pursuant to the application of Paryavaran Suraksha Samiti, Vadodara and Peoples Union for Civil Liberties, Ankleshwar, *inter alia*, challenging the said Procedural Circular, the National Green Tribunal (West Zone) has, vide order dated January 8, 2016, *inter alia* (i) termed the said Procedural Circular illegal and directed the Government of India (and other respondents) to revoke within one month the environmental clearance granted to the company's said bulk drugs plant at Panoli (besides unit(s) of certain other companies), and (ii) consequently directed the company to close down the activities at the said plant within 4 weeks (besides unit(s) of certain other companies).

The company plans to immediately appeal the said order in the Supreme Court and is confident that the Supreme Court will grant relief to the company especially in

light of various technical and factual aspects involved in the matter. The company's said plant has valid NOC/Consent to operate under applicable environmental laws and is operating well within the framework of law.


